This test report is related to the evaluation of irritant effects of cosmetic products when applied in single dose to the intact human skin. The supervision of these tests and the evaluations were carried out by medical staff. The evaluation of skin reactions is made 15 minutes and 24 hours after removal of the sample, according to the scale reported below. A 10x10mm paper sample was applied, after being moistened with a drop of liquid paraffin FU, on the skin of 10 volunteers, of both sex, who during the last month did not participate to any similar analogue test, are not affected by dermatitis, have no history of allergic skin reaction, are not under anti-inflammatory drug therapy. The women are not pregnant.
